About This Code

Supplier Responsibilities

As a Supplier of Carmel Forge, you are expected to:

Maintain a Safe and Responsible Workplace

- Follow all local health and safety rules, policies and procedures.
- Provide personal protective equipment to all employees who need it to complete their job.
- Comply with applicable environmental laws and regulations.
- Adhere to Carmel Forge's Supplier and Contractor policies, procedures and guidelines.

Maintain a Work Environment Free from Discrimination, Harassment or Violence

- Respect the human rights of your employees and others in your business operations and your activities for Carmel Forge.
- Not employ workers that are younger than the minimum legal age for employment where the work is performed.
- Prohibit discrimination, harassment and retaliation.
- Protect employees from workplace violence or threat of violence.

Comply with Labor Laws

- Comply with all applicable laws and regulations regarding wages, hours and work conditions.
- Not use forced or indentured labor, or workers subject to any form of compulsion or coercion, or engage in trafficking in persons.
- Adopt policies and establish systems to procure tantalum, tin, tungsten and gold from sources that have been verified as conflict free, and to provide supporting data on your supply chain for tantalum, tin, tungsten and gold to Carmel Forge when requested.

Engage in Lawful Business Practices

- Maintain and enforce a policy requiring compliance with anti-corruption and anti-bribery laws.
- Not offer or provide, directly or indirectly, anything of value, including cash, bribes, gifts, entertainment or kickbacks, including offers of employment, or participation in a promotion, to any Carmel Forge employee, representative or Carmel Forge customer or to any government official in connection with any Carmel Forge procurement or transaction.

Safeguard Intellectual Property

• Respect the intellectual and other property rights of Carmel Forge and of third parties, including all patents, trademarks and copyrights.

• Avoid transferring Carmel Forge technical information to any third party without the express, written permission of Carmel Forge.

Uphold Competition Requirements

- Avoid sharing or exchanging any price, cost or other competitive information with any third party with respect to any proposed, pending or current Carmel Forge procurement
 - Avoid engaging in any collusive conduct with any third party

Comply with International Trade Laws

- Comply with all applicable export and import control laws and regulations when importing, exporting, re-exporting or transferring goods, services, software, technology or technical data;
- Screen customers and suppliers to ensure compliance with sanction laws and regulations.
- Provide internally-maintained information about country of origin, harmonized tariff codes and commodity classifications to Carmel Forge when requested.

Engage in Fair Accounting Practices

• Ensure that all documents, invoices communications and accounting are accurate and honest.

Quality

- Implement processes to detect, communicate and correct defects, ensuring products and services meet quality and regulatory standards.
- Complete all required inspections and tests with authorized and qualified personnel, and ensure certifications are accurate.

Avoid and Prevent Fraudulent Activity

- Avoid any practices involving deceit, trickery, dishonest practices, or breach of confidence, intentionally perpetrated for profit or to gain some unfair or dishonest advantage. This includes, but is not limited to, falsification of information, intentional omission, false pretenses, and deliberate misuse of qualified resources, certification, qualification or authorization.
- Not offer or provide counterfeit goods or misrepresented goods or services.
